

# Impact Aid Survey Directions

The Tomah Area School District receives federal funding for students who have parents employed or living on the below federal properties. It is very important to get as many of these forms returned to us as possible.

## DIRECTIONS FOR COMPLETELY FILLING OUT THE IMPACT AID SURVEY FORM

- **Student(s) Information and Student(s) Complete Address**
  - Complete student information completely along with their complete address
    - No PO Boxes
    - Please complete an additional form if you need more space for children
    - The only property considered federal property to live on would be the Low Rent Housing (also known as the Lakeside Apartments on Williams Street.
  - If you live at the Lakeside Apartments you only need to complete Student(s) Information and Student(s) Complete Address
- **Parent/Guardian Employment Information: Civilian**
  - Complete this section if the parent/guardian with whom the student resides with was employed on federal property as of 9/15/23
    - Federal Property Options:
      - Fort McCoy
      - Volk Field/USPFO
      - Tomah VA Medical Center
        - VA Medical/Off
          - You work at the VA but do not reside on VA Property
        - VA Medical/On
          - You work at the VA and reside on VA Property
      - Necedah National Wildlife Refuge
      - Oxford Correctional
    - Please completely fill out this section and check the appropriate box
- **Parent/Guardian Employment Information: Full Time Active Duty Uniformed Services**
  - Complete this section if the parent/guardian with whom the student resides with was on active duty in the Uniformed Services of the United States as of 9/15/23
    - Completely fill out each box and check the branch of service
    - This includes parent/guardians that are deployed within the United States or to other countries
    - National Guard and Reserves are **NOT** considered full time active duty
      - If you are in the National Guard/Reserves and work on federal property, you would be considered a civilian employed on federal property
      - If you were called to active duty under Title 10
        - Must be activated as of survey date
        - Copy of orders must be dropped off at the District Office (129 W. Clifton Street Tomah, WI 54660) to be considered active duty
- **Parent/Guardian Information: Native American Lands/Other Trust Land**
  - Complete this section if you are employed on Native American Land/Other Trust Land or are residing on Native American Land/Other Trust Land
    - Fully complete this section
    - Housing and employment on Sime Ave are **NOT** considered Trust Land
    - Employment at Ho-Chunk Youth Center on Julie Street is **NOT** considered Trust Land
- **Parent/Guardian Signature and Date**
  - Forms must be **completely filled out, signed, and dated**
